Wedding Policies & Requirements

1. I have adopted the following wedding policies because my desire is to help you have a great marriage not just a memorable wedding. Also know I am confident that we will create a wedding ceremony that celebrates your unique love story. You can find more information at www.ericchols.net/weddings.
2. Please email eric@ericchols.net to check Eric's calendar for availability to perform your ceremony.
3. It is strongly encouraged that both the bride and groom participate in pre-marital counseling sessions. Eric will perform the pre-marital counseling for a fee of \$300. This requirement is waived if the couple is participating in formal pre-marital counseling with a trained counselor.
4. If Eric conducts the pre-marriage counseling, couples are required to complete the assessment at www.couplecheckup.com prior to the pre-marital counseling sessions and email the results to eric@ericchols.net.
5. The bride and groom's questionnaires must be completed prior to the first pre-marital counseling session. These will be sent as an additional attachment.
6. A \$250 honorarium for your wedding ceremony should be written as a gift to my wife, Nicole Echols, as a "thank you" for lending me out for the time that I am away from home on the weekend of your wedding.
7. **Don't forget:** It is your responsibility to bring your marriage license to the ceremony for Eric to sign.
